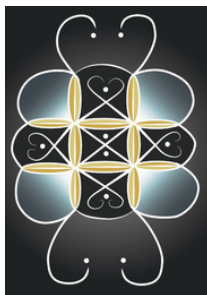

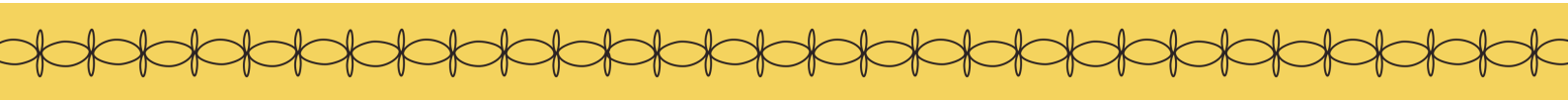

# WHY BECOME A MEMBER?

VANGO is the national umbrella organisation for all non-government organisations and community-based organisations operating in Vanuatu.

**Its goal is to 'build a vibrant NGO sector which accurately represents the interests of Ni-Vanuatu people and disadvantaged groups and promotes local development issues'**

Membership to VANGO is an important means of demonstrating your support for this goal and contributing to improving our communities for everyone.

For Civil Society Organisations, VANGO membership is also aligned with the 2017 Vanuatu Government NGO policy and the NGO Act currently being developed.

## **The benefits of VANGO membership include:**

- Access to VANGO newsletters and publications to keep up to date about VANGOs work
- Opportunity to get involved and feed into advocacy campaigns and initiative
- Inclusion in the mapping and soon to be launched CSO directory
- Invitation to attend member only events and trainings and AGM voting rights

**All voting members must be approved by VANGO and meet minimum governance requirements**, for example be able to demonstrate a functioning Management or Association Committee and Constitution.

**Affiliate membership** is available for Government agencies, donors and others who would like to demonstrate their support for VANGO and its objectives. Affiliate members do not have voting rights and are more limited in how they may engage with VANGO activities.

**Membership fees are structured around different categories and are paid on an annual basis.** Pro-rata membership fees may be applicable upon request for new members.
